**Sub: Filling up the posts on deputation basis in NACEN, at Vadodara---reg.**

The options are invited to fill up the vacancies in the National Academy of Customs, Excise & Narcotics, at Vadodara **on deputation** basis. Incumbent should necessarily have operating knowledge of Computers to undertake correspondence, reports and other such works. The period of deputation will be normally three years subject to their suitability and aptitude for training. Option once exercised will be final and in the event of selection by the academy the candidate will not be allowed to withdraw the same. The request for relieving before completion of tenure will not be entertained in the normal course and that application for another post on deputation will also not be entertained while on deputation to this Academy.
