**TENDER NOTICE FOR setting up of an indoor 10m Air Pistol/Rifle Shooting Range (including spectator area) and Supply & Installation of Range/Shooting Equipment**

1.1 Notice Inviting Tender (NIT) for setting up of an indoor 10m Air Pistol/Rifle Shooting Range (including spectator area) and Supply & Installation of Range/Shooting Equipment to the National Academy of Customs, Indirect Taxes & Narcotics (NACIN), Faridabad, NACIN Complex, Sector 29, Faridabad, 121008.

1.2 Online bids are invited under Two Bid Systems for setting up of an indoor 10m Air Pistol/Rifle Shooting Range (including spectator area) and Supply & Installation of Range/Shooting Equipment to the National Academy of Customs, Indirect Taxes & Narcotics (NACIN), Faridabad, NACIN Complex, Sector 29, Faridabad, 121008.

Contractors are advised to follow the instructions provided in the 'Instructions to the Contractors/Tenderer for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <https://eprocure.gov.in/eprocure/app>.

1.5 Tenderer who has downloaded the tender from the NACIN website [www.nacin.gov.in](http://www.nacin.gov.in) and Central Public Procurement Portal (CPPP) website <https://eprocure.gov.in/eprocure/app>, shall not tamper/modify the tender form including downloaded price bid template in any manner.

1.6 EMD Payment: Earnest Money Deposit of Rs.        /-(Rupees 1,00,000 (One Lakh only) is to be deposited **in the form of Demand Draft from a Scheduled Commercial Bank in favor of PAO CBEC along with their bids.** The EMD received from the tenderers will be returned without interest after the process of award of contract. Bidders are required to submit the details of EMD payment at the time of Bid Preparation.

2.1 Online bids are invited under Two Bid systems for engagement of an Agency for setting up of an indoor 10m Air Pistol/Rifle Shooting Range (including spectator area) and Supply & Installation of Range/Shooting Equipment (as per Annexure-I) to the National Academy of Customs, Indirect Taxes & Narcotics (NACIN), Faridabad, NACIN Complex, Sector 29, Faridabad, 121008.

**2.2 (A) Eligibility Criteria** The tendering Agency must fulfill the following conditions in order to be eligible for technical evaluation of the bid.

i. The agency/ bidder should have proof of setting up of an indoor 10m Air Pistol/Rifle Shooting Range (including spectator area – as applicable) and Supply & Installation of Range/Shooting Equipment during the preceding past 3 years to any Govt. Organizations/PSUs/Academic Institutions /Reputed Organizations.

ii. The agency/ bidder should be having PAN (Permanent Account Number) allotted by the Income Tax Department.

iii. The firm/ agency should be registered under Sales Tax/ Service Tax/ GST Act as applicable.

iv. The annual turnover of the bidder for the past 3 years should not be less than Rs.50.00 lakh per annum.

v. There should be no legal suit/ criminal case pending or contemplated or legal notice having been served to this effect against the Proprietor of the Agency or any of its Directors (in case of Pvt. Ltd. Company) on grounds of moral turpitude or for violation of any of the laws in-force and should not be black listed by the any Government organization.

vi. The Registered Office of the Agency should be preferably located in Delhi/ NCR.

vii. The site inspection should be done by the seller on his own cost before bidding as any excuse in this regard would not be entertained by this office later on.

## **2.2 (B) Instruction to Tenderers**

### **Submission of Tender**

The tender shall be submitted online in Two parts, viz., Technical bid and Financial bid. All the pages of bid being submitted must be sequentially numbered by the bidder irrespective of nature of content of the documents before

uploading. The offers submitted by Telegram/ Fax/ email shall not be considered. No correspondence will be entertained in this matter

## **2.2 (C) Technical bid:**

The following documents are to be furnished by the bidders along with the Technical Bid as per Annexure-II of the tender documents.

- i. List of clients with a copy of the work order setting up of an indoor 10m Air Pistol/Rifle Shooting Range (including spectator area – if required by such clients) and Supply & Installation of Range/Shooting Equipment in Govt. Organization/ PSU/ Academic Institutions/ Reputed Organization during last 3 years.
- ii. The firm should be having PAN (Permanent Account Number) allotted by the Income Tax Department, document proof of the same has to be enclosed.
- iii. The firm/ agency should be registered under Sales Tax/ Service Tax/ GST Act as applicable. The document proof of the same has to be enclosed.
- iv. The annual turnover of the bidder for the past 3 years should not be less than Rs.50.00 lakh per annum and proof of the same should be submitted in the form of IT return/ Audited Balance Sheet/ Work Order.
- v. There should be no legal suit/ criminal case pending or contemplated or legal notice having been served to this effect against the Proprietor of the Agency or any of its Directors (in case of Pvt. Ltd. Company) on grounds of moral turpitude or for violation of any of the laws in-force and should not be black listed by the any Government organization. The self-certification as per annexure-III should be enclosed.
- vi. The Registered Office of the Agency should be preferably located in Delhi/ NCR. The proof of the same shall be enclosed.

## **2.2 (D) Financial BID:**

Financial bid is to be submitted as per format given in Annexure-IV (online). Bidder shall not tamper/ modify downloaded financial bid template in any manner. In case, if the same is found to be tampered/ modified in any manner, tender will be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with NACIN.

## **3. Terms and conditions**

1. The rate quoted should be in rupees inclusive of all charges e.g. packing, forwarding local taxes, railway freight, transit insurance, for outside firms and delivery at NACIN, Sector-29, Faridabad. The total price shall include all accessories/peripherals/spares required for setting up of an indoor 10m Air Pistol/Rifle Shooting Range (including spectator area) and Supply & Installation of Range/Shooting Equipment. The setting up process should be initiated within 20 days of the work order date failing which a penalty of Rs.1000/- (Rs. One

Thousand only) per day, till the day the work is initiated, shall be deducted from the final payment.

2. Detailed specifications with the mention of make and model/ Version of each item should be clearly given supported by the illustrated pamphlets wherever possible. The accessories/spares included in the Range/Shooting equipment should also be clearly mentioned. The setting up, installation of Range/Shooting equipment and operationalization of the Shooting range as a whole (including the spectator area) is the responsibility of the bidder.

3. The entire indoor range and Range/Shooting equipment should conform to ISSF / NRAI standards. Wherever applicable, the items having standard certified ISO/ ISI etc. shall be given preference by NACIN.

4. The bidder has to quote the price for all the items as per enquiry strictly. Incomplete price bid will not be considered at all for financial evaluation.

5. Losses or damage in transit shall be borne by the Supplier and offered prices should be valid at least for Six months from the last date of receipt of tenders.

6. Supply of the placed order in part shall not be accepted.

7. The bidder has to submit Earnest Money Deposit (EMD) amounting to Rs. 1,00,000/- (Rupees One Lakh Only) **in the form of Demand Draft from a Scheduled Commercial Bank in favor of PAO CBEC along with their bids.** The EMD received from the tenderers will be returned without interest immediately after the process of award of contract is over. Bidders are required to submit the details of EMD payment at the time of Bid preparation. The bids received without EMD shall not be considered for technical evaluation.

**8. Performance Guarantee- Performance Guarantee/ Security Deposit of 5% of total value (Range/Shooting Equipment + AMC)** shall have to be deposited within 20 days of placing order in the form of FDR/ Bank Guarantee from a Nationalized Bank. This shall be valid upto 90 days beyond warranty/ AMC period. Performance Guarantee will be returned without any interest after successfully completion of AMC period. This amount, however, be confiscated in case of refusal or failure to provide satisfactory services or backing out in midstream.

**9. Terms of Payment-** Payment will be made to the supplier on successful completion of setting up of the indoor range (including spectator area), delivery and installation/ commissioning of all the requisite Range/Shooting equipment/accessories/spares at site as per the supply order placed by the respective units and certificate issued by NACIN's Committee constituted for this purpose. The quality/ make, brand of equipment shall be strictly as per financial quotation. No advance payment shall be released. The payment of AMC will be made on yearly basis after satisfactory completion of said service.

**10. Warranty-** The vendor shall provide Five year onsite comprehensive warranty for the Range/ Shooting Equipment/accessories/spares being supplied irrespective of manufacturer warranty. Any failure in the equipments or a subsystem thereof should be rectified within a maximum period of 7 days of lodging a complaint. Any defect attributable to poor workmanship or use of substandard quality material during manufacturing process must be replaced with new

one free of cost at site by the supplier irrespective of the guarantee/ warranty clauses between the supplier and his dealer OEM. No additional charges shall be paid to him by NACIN. Warranty certificate for all the Range/Shooting equipment commencing from the date of commissioning shall be given at the time of supply of the same.

12. A certificate to the effect that Range/Shooting equipment supplied are fully operational and no additional accessory is required for them to be fully functional, shall be issued by the vendor. NACIN reserves the right to refuse payment in the event of not furnishing this certificate.

13. Complete user, technical and service manuals/ installation drawings/ documentation and accessories/spare parts catalogue are to be provided along with the supply of the item.

14. Failure to comply with all the terms and conditions mentioned herein would result in the tender being summarily rejected.

15. Conditional tenders shall not be accepted.

16. Any cutting and overwriting in the financial bid shall not be accepted.

17. NACIN reserves the right to reject any or all the tenders without assigning any reasons whatsoever.

18. **Penalty clause (i)**- The commencement of delivery and setting up of the Range/Shooting Equipment shall not be more than ONE month from the date of issue of supply order. In case of delay, a penalty @ 1% of the total amount per month shall be deducted on pro-rata basis for the delayed period and which would not be more than 2 months from the date of issue of work order after which NACIN reserves the right to cancel the work order and award it to the next bidder. No claim or damages of any sort would be available to the vendor in case the work order is cancelled due to delay as mentioned above.

19. **Penalty clause (ii)**- The vendor has to repair the Range/Shooting Equipment (on site) at NACIN within 10 days of a complaint being lodged. In case of delay, a penalty would be charged @ 1% of cost of item per week for delayed period. The penalty may be waived if competent authority decides so on merit of the reason.

20. **ARBITRATION CLAUSE:** In case of any disputes between the parties viz. National Academy of Customs, Indirect Taxes & Narcotics (NACIN) on one hand and the agency/ firm awarded the Contract on the other hand, arising out on account of scope of the work and other mandatory liabilities as stated in the Contract Agreement, the dispute shall be referred to Pr. DG NACIN, Sector-29, Faridabad.

21. **Evaluation Criteria:** The Technical bids will be scrutinized on the basis of Basic Eligibility Criteria as detailed in Section-2.2 (A) & 2.2 (C) of the Tender Document. Financial bids will be opened only of the technically qualified bidder. **The L-1 would be decided on the basis of total expenditure on Range (including spectator area) / Shooting Equipments and AMC charges taken together.**
